A family suite is a self contained unit of accommodation made up of one queen size bedded room, a separate twin bedded room and a shared bathroom. A fifth guest under 10 years of age can be accommodated on an additional fold-out bed.

Travel cots are available (although limited and must be requested in advance) and are provided at an additional cost of £10.00

Fold out beds are available for a child up to 10 years (although limited and must be requested in advance) and are provided at an additional cost of £15.00

The total accommodation is made up of **4 twin bedded en-suite rooms, 10 queen size en-suite rooms and 3 family suites**. First refusal will be given to wedding guests up to 2 months before the date of the wedding after which time all unallocated rooms will be released for external bookings.

Payment for rooms should be made no later than 7 days prior to arrival.



# Terms & Conditions

1. Booking Confirmation ~ Slater's Country Inn requires a payment of £1000 to secure the date which would act as a non-refundable deposit. The hotel reserves the right to cancel a provisional booking if payment is not received after 14 days.
2. Payment ~ A further payment of £1000 is required on or before 1st January each year before the year of your wedding. Three months prior to the date of your wedding a total of 70% of the anticipated total should be paid. The final balance should be paid no later than 14 days before your wedding day. These payments are non-refundable or transferable. Any changes to numbers made less than 14 days before your wedding will incur an administration fee of £25. Slater's Country Hotel & Inn reserves the right to charge the customer an interest rate of 3% above the Bank of England base rates on all late payments.
3. Numbers ~ For a Friday or Saturday in May, June, July, August and September a minimum number of 50 guests for a Wedding Breakfast and 100 guests for an Evening Reception are required. Final numbers to be confirmed 21 days in advance of your wedding day and this will be the minimum number, which will be charged. Please note that 100% of the evening guests must be catered for. Any reduction in numbers within 14 days of your wedding date will be non-refundable or transferable.
4. Cancellation ~ Cancellations will only be accepted in the event of a cancellation there will be a charge of:  
A Over 12 months in advance any payments made to date are forfeited  
B 6 – 12 months in advance 30% of the total anticipated charges  
C 3 – 6 months in advance 70% of the total anticipated charges  
D Less than 3 months 90% of the total anticipated charges  
E 14 days in advance 100% of the total anticipated charges
5. Civil Ceremonies ~ Slater's Country Hotel & Inn is fully licensed for Civil Ceremonies and couples are required to book the registrars themselves. We can accommodate wedding ceremonies from 12pm with the optimum time being 2pm. Slater's Country Inn comes under Staffordshire Registration Services and therefore it is Staffordshire Registrars who you need to contact directly to book. Please note that there is a separate payment needed to be made for this which is payable directly to Staffordshire Registration Services. You can see fees online or contact the Registrars by phone on 0300 111 8001.
6. Access and Timings ~ You will have access to the venue from 8am on the day of your wedding. Please note The Bridal Suite is not accessible before 12pm. The Customer must ensure that The Venue shall be cleared of materials, equipment and decorations brought there, including those brought by external suppliers within the time mutually agreed between The Venue and The Customer. The Venue holds no responsibility for items left after this time. Events must finish at the time agreed when booking and an extension of time may not be possible. The licensed bar will finish at 12.00am and the entertainment will finish at 12.30am. All non-residential guests and suppliers must leave the premises by 12.45am. All external doors will be locked by 1am. Events must finish at the time agreed when booking and an extension of time may not be possible.
7. External Suppliers ~ All external suppliers (venue dresser, florist, photo booth etc) can only enter the venue at the agreed times provided to The Customer and their information must be relayed to your Wedding Planner prior to your wedding day. The Customer should ensure that entertainment contractors (photo booth, band, disco etc) provide The Venue with a copy of their public liability insurance and relative P.A.T certificates. Such certification must be received prior to your final planning meeting. The use of bouncy castles, strobe lighting, Chinese lanterns, party poppers, lit wax candles, smoke machines, non-biodegradable confetti, and confetti cannons are prohibited. It is the responsibility of The Customer to ensure all external suppliers receive a copy of these terms and conditions and agree to abide by them. In the event of a failure by external suppliers in this respect, The Customer will be accountable.
8. Buffet Food ~ The buffet food will be provided from the time that has been agreed in the final meeting, and this can only be left out for a maximum of an hour and a half for hygiene and health & safety reasons.
9. Food and Beverages ~ The Customer will ensure that no food or beverages of any kind (excluding wedding cakes) are brought onto the premises. Slater's Country Hotel & Inn reserves the right to remove any food or beverages that have not been supplied by The Venue due to food hygiene reasons. Alcohol that has not been purchased on the premises is strictly prohibited.





# Terms & Conditions continued.

10. The Wedding Cake ~ Slater's Country Hotel & Inn does not take any responsibility for the Wedding cake, and we only accept delivery of the cake on the morning of the wedding. Any damage caused to the cake in our possession will not be compensated for, the risk remains with The Customer. Any fresh food items to accompany Cheese Wedding Cakes and Pork Pie Wedding Cakes cannot be supplied by The Customer. The Venue will provide accompaniments at an additional charge agreed prior to the event. We will cut and serve your cake on request and save any cake that is left over. If you have not collected your remaining cake the following morning then Slater's Country Inn reserves the right to discard it.
11. Damage ~ The Customer is responsible to Slater's Country Hotel and Inn for any damage caused by their guests, suppliers or employees.
12. The Right To Exclude or Eject Persons ~ The Venue reserves the right to exclude or eject, as it thinks fit and reasonable, any persons from The Event or The Venue who it shall consider objectionable, including any external suppliers engaged by The Customer.
13. Equipment and Property ~ The Customer's own equipment and property is brought to Slater's Country Hotel and Inn at their own risk and Slater's Country Hotel and Inn accepts no liability for loss or damage. All personal items should be removed the following day. Any items not claimed within 21 days following the wedding may be disposed of.
14. Pricing ~ All prices will be confirmed no later than 3 months before your wedding day. Price Variation ~ Slater's Country Hotel and Inn reserves the right to increase prices in the event of circumstances beyond control, e.g. increase in VAT.
15. Force Majeure ~ If Slater's Country Hotel and Inn is limited or hindered from hosting the event or providing any facility booked by the client due to circumstances beyond its control e.g. Government intervention, pandemics, acts of God, civil disturbance, war, national or local disaster, strikes, labour disputes, then the liability of Slater's Country Hotel and Inn to The Customer shall not exceed the amount paid by the client to Slater's Country Hotel and Inn in respect of the event.
16. Contract ~ When a booking is confirmed in writing a contract is deemed to exist. This contract shall be governed in all respects by English Law. It can only be modified by a supplementary written contract. Slater's Country Hotel and Inn will endeavour to provide the contracted event room. However, Slater's reserves the right to relocate the event to a different room/area of the hotel, whilst fulfilling all other criteria of the booking.
17. Accommodation ~ We have provisionally booked 17 bedrooms for this date and these will be held until 8 weeks prior to your wedding date. After this time any unallocated rooms will be released for general sale. Any pre-booked rooms not paid within 7 days of arrival will be released.
18. No oral representations or arrangements are recognised by The Venue and the conditions of this agreement can be modified only by a supplementary written contract. Both parties must sign the supplementary written contract.
